1. Place of Work

Your place of work would be: Samdareeya Mall,3<sup>rd</sup> Floor, Madhotal ,Jabalpur,482001.

2. Working Hours

The normal working hours are (working hours ) with 30 mins of lunch break Monday through Saturday. However due to work exigencies employees may be required to work at different timings as prescribed by the manager from time to time.

- 3. Variable Pay
  - a) All associates are currently eligible to participate in the variable compensation plan relevant to their role and projects handled. - No any other external project will be handled in the company premises. If found otherwise serious action will be taken against the person (Advrtu Associates).
- The person (Advrtu Associates) shall maintain proper discipline and attire in the office premises.
- Allotted project can be replace or taken accordingly on the basis of Project Metrics.
- Kindly refrain from discussing your remuneration from other members.
